- 18. If You are the successful application the Lessor will provide You with a proposed Residential Tenancy Agreement for the Premises which will grant You the option of entering into a Residential Tenancy Agreement:
 - (a) if You sign the Residential Tenancy Agreement, comply with all the stipulated requirements for the creation of a binding Residential Tenancy Agreement as set out in Part C of the document (eg returning the document to the Property Manager by the stipulated time, paying full stipulated rental and bond); and;

 - "Option Fee" means a payment as referred to in section 27(2)(a) of the Act. The amount of the Option Fee is specified in Part A of this application. The amount of the Option Fee is capped as follows:
 - i) where the weekly rental under the Residential Tenancy Agreement is \$500 or less, an Option Fee of up to \$50 is payable;
 - (ii) where the weekly rental under the Residential Tenancy Agreement exceeds \$500, an Option Fee of up to \$100 is payable:
 - (ii) where the Residential Tenancy Agreement is for residential premises south of the 26th parallel of south latitude and the weekly rent is \$1,200 or more, an Option Fee of up to \$1,200 is payable.

"Premises" means the address specified on the first page of this document. Any items included or excluded will appear in Part A of the proposed Residential Tenancy Agreement.

"Property Manager" means the real estate agent appointed by the Lessor to lease and manage the Premises.

"Residential Tenancy Agreement" means an agreement in writing in the form prescribed by the Act, comprising of Parts A, B and C. Part C will include additional special conditions as agreed between the parties.

"You" or "Your" means the person or persons making the Application to Lease the Premises.

- (b) All acts and things that the Lessor is required or empowered to do may be done by the Lessor or their Property Manager.
- 21. You agree that for the purpose of this Application, the Lessor or Property Manager may make enquiries of the persons given as referees, next of kin or emergency contacts provided by You, and also make enquiries of such other persons or agencies as the Lessor may see fit.

The personal information You give in this Application or collected from other sources is necessary for the Lessor or Property Manager to verify Your identity, to process and evaluate the Application, to manage the tenancy and to conduct the Property Manager's business. Annexure A

1.Routine Inspections

Digital photos of the interior and exterior may be taken when inspections are carried out for the purpose of informing the owner of the property condition. These photographs maybe shared by a third party including the owner

The tenant agrees any maintenance required to the premises will be reported to the agent immediately if the matter is urgent or as soon as

practical for non urgent matters. This advice can be communicated verbally, in writing, via email or online at http://dgre.com.au/maintenance.aspx Once an appointment time and date has been mutually agreed between the tenant and the appointed contractor the tenant will be charged for any call out fee normally payable if the tenant fails to meet the contractor at the per-determined time and date. The tenant will be charged for any repairs deemed to be caused at the fault of the tenant as determined by the contractor.

3.Exhaust fans, Ventilation & Mould

The tenant acknowledges exhaust fans must be cleaned on a regular basis. If the property is not fitted with an exhaust fan it is the tenants responsibility to take all reasonable efforts to prevent the build up of mould, mildew, condensation and odours in the property by means of enabling sufficient air flow through the premises.

4 Wooden/timber floors

If the property has exposed timber floors and / or floor tiles ALL furniture must have protective coasters and / or felt protection to guard against scratching.

5.Reticulation

The tenant acknowledges the reticulation (if any) is to be run in accordance with current water conditions. Any faults should be reported to the agent immediately. If the gardens are maintained by the owner or gardener it remains the tenants responsibility to report any issues with the reticulation and/or the gardens.

6. Timber Pest Inspection

The tenant acknowledges that the property may be subject to periodic or annual Timber Pest Inspections and in the event that positive activity is found it may be necessary for a treatment to be applied

7.Smoke Alarm and RCD Testing

The tenants are aware smoke alarm and RCD testing will be carried out on an annual basis by an electrician and/or fire safety contractor, Should the smoke alarm not be functioning the tenant is to contact the agent immediately

8.Fireplaces

Tenants are not to use open fireplaces unless instructed otherwise. Combustion or enclosed fires can be used providing the agent has granted permission.

9.Dishonoured Payments

The tenant shall be responsible for any bank fees incurred as a result of any dishonoured payments by the tenant to the agent and shall reimburse the agent for the cost of any dishonoured as charged by the agents bank

10. Parking on Lawns

The tenant shall not to park any boat, trailer, motor home, caravan or vehicle on the lawns or verge and also shall to use oil drip trays on driveways and or carport/garage to prevent oil stains from vehicles.

11.Furnished properties

Where applicable, the tenant agrees to use mattress protectors on any beds at all times and upon vacating to have all provided linen freshly laundered. Failure to do so will result in dry cleaning costs which will be passed onto the tenant. All furniture and equipment must be returned to its original location upon the commencement of the tenancy as described in the property condition report.
